2023 Medicare Part B Premium Costs & IRMAA

The standard Part B premium amount in 2023 will be \$164.90. Most people will pay the standard Part B premium amount. If your modified adjusted gross income, as reported on your IRS tax return from 2 years ago, is above a certain amount, you'll pay the standard premium amount and an Income Related Monthly Adjustment Amount (IRMAA). IRMAA is an extra charge added to your premium.
